ADOPTION AGREEMENT

I/We, _____, the undersigned "ADOPTER" agrees to all conditions set forth within this Adoption Agreement "AGREEMENT" established by the Columbia-Willamette Beagle Club "BEAGLE RESCUE PROGRAM". This Agreement will commence on _____ and continue in full force until notification of Adopter of death of the dog, repossession or return of the dog to the Beagle Rescue Program. TERMS OF AGREEMENT

1. The adopted dog will live in the Adopter's home as a permanent member of the family.
2. The adopted dog is spayed/neutered and therefore not for breeding purposes.
3. If, for any reason the adoption is not satisfactory to the Adopter, or the Adopter fails to comply with the terms and conditions of this Agreement, the dog must be returned to the Columbia-Willamette Beagle Rescue Program at the expense of the Adopter. Donations made to the Beagle Rescue Program at any time shall not be construed as consideration or payment for the adopted dog and therefore even in the event the dog is surrendered for any reason, there shall be no refunds of donations.
4. The adopted dog may not be transferred to any other person, firm, corporation or entity for any reason whatsoever without approval of the Columbia-Willamette Beagle Rescue Program and if so approved, that person, firm, corporation or entity shall sign a like Agreement with the Beagle Rescue Committee.
5. The adopted dog will be placed on a vaccination program established by the Adopter's veterinarian, in order to protect the health of the adopted dog. The adopted dog will, under no circumstances, be transported in the bed of an open-bed pick-up truck. Further, the dog will not be tied or chained except as a temporary safety measure.

6. The adopted dog should have positive identification in the form of tattoo, or microchip and collar with current license tag and nametag indicating Adopter's address and/or telephone number at any time the dog is outside the home of the Adopter. If micro-chipped, CWBC will be listed as third contact after Adopter/s & Adopter/s veterinary clinic. Please select one: agree _____ (initial) do not agree _____ (initial) to this stipulation for microchipping-adopted dog.
7. The Beagle Rescue Program reserves the right to call and/or visit Adopter's premises to check the welfare and well being of the adopted dog. If Adopter is found to have violated any of the terms and conditions of this Agreement during the entire lifespan of the adopted dog, the Beagle Rescue Program reserves the right to terminate this Agreement, at which time the dog must be surrendered.
8. In the event of litigation to enforce this Agreement or any provision thereof, the filing will take place in Multnomah County, State of Oregon. The prevailing party, in addition to other release awarded, shall be entitled to recover its reasonable attorney fees, filing costs and fees at trial and upon appeal, if any.
9. Adopters grant full permission for CWBC Rescue to take a photograph of adopted dog with Adopters for purposes of advertising the rescue program, posting on the internet, or to be used in any other media which may benefit the rescue organization. There shall be no compensation to Adopters if photo is used in this manner.
10. Adopter/s understand that the adoption fee is \$_____ is not refundable, regardless of whether the dog is returned to rescue or not. Adoptions fees are used solely for the care of dogs in our rescue program. The primary use of funds is for medical care of current and future dogs in our program.
